## Tournament Rules & Captain Meeting Information

1. Food, drinks, and coolers are not allowed inside the gym. There is a concession stand inside the facility. You must consume all food and beverages in the hallways outside the court areas. Only water is permitted inside the gymnasium.
2. Alcohol, pornographic material, and other similar items are prohibited in school facilities.
3. All NAGVA rules are in effect.
4. Molten volleyballs will be used in this tournament.
5. All uniforms must have numbers clearly visible on the front and back.
6. Play is automatically over when a player enters another court while in pursuit of the ball.
7. The ball is out of play if it hits the ceiling or any other equipment, device, etc. on the opposite site of the court.
8. The ball is out of play if it hits a dividing net.
9. Players may move the dividing nets (between courts) as long as it is done by the player pursuing the ball and if it is done in a manner that does not cause a distraction to another court, potentially injure someone, or damage equipment.
10. The ball may continue to be played if it hits the ceiling or other equipment, device, etc. if on the same side of the court and if it is still playable (not the third hit).
11. Teams will play four matches consisting of two 25-point [4-25] rally games per match, with a 27-point cap and two time-outs allowed per team per game.
12. Teams will be allowed a warm-up period before each match and allotted a specified amount of time to play both games.
13. All pool play matches will be timed by a central clock. All matches will begin and end at the same time. Teams will be signaled at the beginning and end of each match. The clock will not stop between the first and second game. A three-minute warning will be given toward the end of each match. After this warning, no time-outs may be taken, however, substitutions will be allowed. If play is in progress when the end-of-match signal is given, the point will be played until the ball is dead. The game may end in a tie.
14. Forfeits will be strictly enforced according to NAGVA / USA Volleyball rules (e.g., if a playing team is not ready when a match is scheduled to begin). If the assigned working team is not present and ready to start a match, they will forfeit the first game of their next match, inclusive of Double Elimination rounds.
15. The USA Volleyball / NAGVA 12 / UNLIMITED substitution rule will be in effect.
16. Teams will be charged the following fees if they do not have certified referees:
  - \* \$30 for a certified up-referee (per match); and
  - \* \$30 for a certified scorekeeper (per match).
17. All decisions by referees are final. Any protest must be registered with the Tournament Director immediately following the completion of the match involved. Any delay will forfeit the protest.
18. The Tournament Director reserves the right to reschedule matches to other courts in order to keep the tournament on schedule. In the event of such changes, teams will be given as much advance notice as possible.

All pool play will take place on Saturday, September 12th. Pool play schedules are provided below. Molten volleyballs will be used in this tournament. All current NAGVA rules will be in effect. All uniforms must have numbers clearly visible on the front and back.

Teams will play four matches consisting of two 25-point rally games per match (starting at 4), with a 27-point cap and two time-outs allowed per team per game. Teams will be allowed a warm-up period before each match and allotted a specified amount of time to play both games.

All pool play matches will be timed by a central clock. All matches will begin and end at the same time. Teams will be signaled at the beginning and end of each match. The clock will not stop between the first and second game. A three-minute warning will be given toward the end of each match. After this warning, no time-outs may be taken, however, substitutions will be allowed. If play is in progress when the end-of-match signal is given, the point will be played until the ball is dead. The game may end in a tie.

Forfeits will be strictly enforced according to NAGVA / USA Volleyball rules (e.g., if a playing team is not ready when a match is scheduled to begin). If the assigned working team is not present and ready to start a match, they will forfeit the first game of their next match, inclusive of Double Elimination rounds. The USA Volleyball / NAGVA 12 / UNLIMITED substitution rule will be in effect.

Due to the recent outbreak of H1N1, we will not be providing whistles for the officiating teams, so please bring your own. Depending on availability, whistles may be purchased on-site.

In order to help save you money, please be sure you have at least one certified up-referee and one certified scorekeeper. Teams will be charged the following fees if they do not have certified referees:

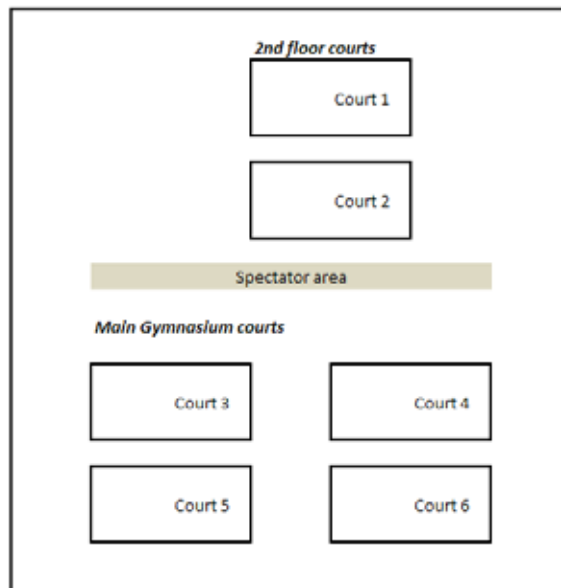
- \$30 for a certified up-referee (per match); and

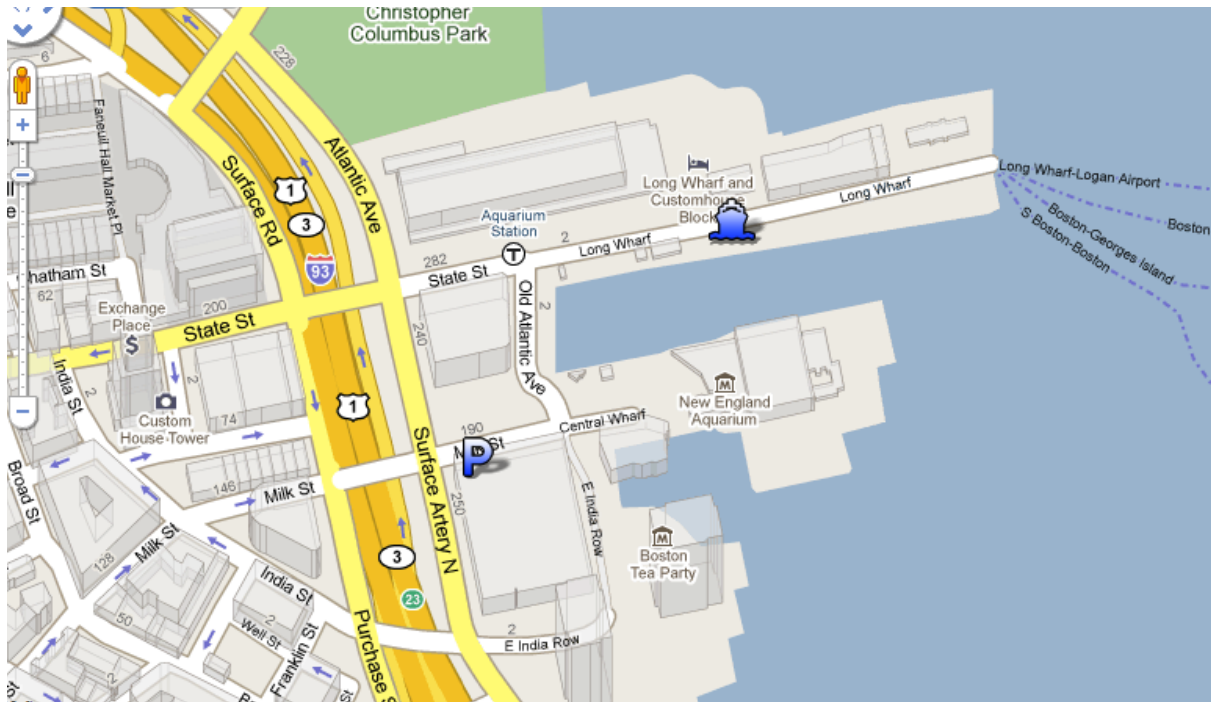

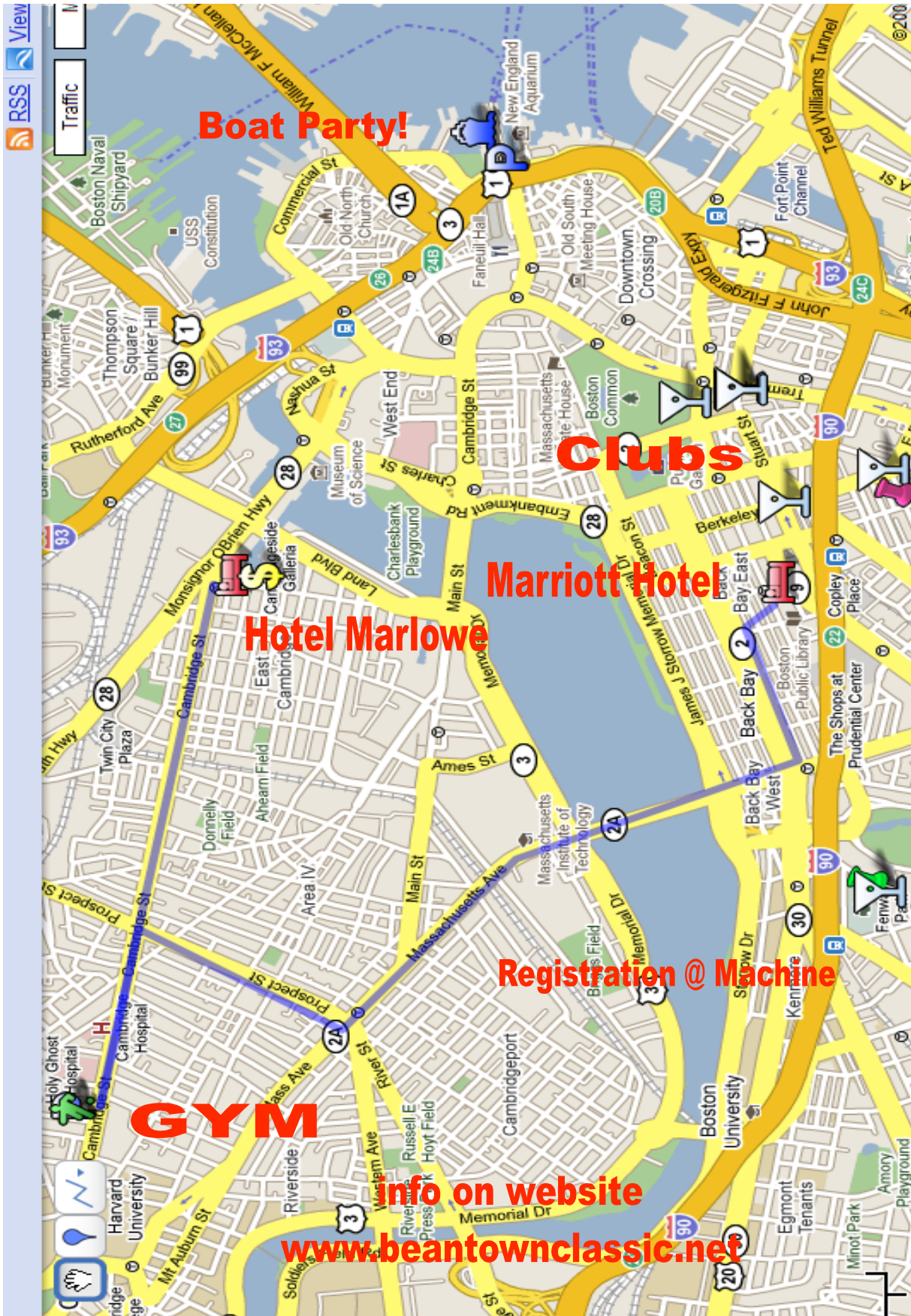
